Under these laws, consumers have the right to:

- Protect against the marketing of hazardous products, goods and services
- The free flow of reliable information about the quality, quantity, potency, purity and price of goods or services
- Protect against exploitation and unfair trade practices
- Access to a variety of prices and competitively priced goods and services
- A means to express opinions and complaints and to be heard in an appropriate forum
- Information and education on consumer products and services
- Redress through the courts for unfair practices

Consumers also have the right to accuracy on their credit reports. Banks and credit card companies have a responsibility to provide correct and accurate information to the credit reporting agencies.
